

## PRIVACY POLICY

Adkev, Inc. ("Company" or "We") respect your privacy and are committed to protecting it through our compliance with this policy.

This policy describes the types of information we may collect from you or that you may provide when you visit the website [www.adkev.com](http://www.adkev.com) (our "Website") and our practices for collecting, using, maintaining, protecting, and disclosing that information.

This policy applies to information we collect on this Website and in email, text, and other electronic messages between you and this Website. It does not apply to information collected by us offline or through any other means, including on any other website operated by Company or any third party or any third party, including through any application or content (including advertising) that may link to or be accessible from or on the Website.

Please read this policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our Website. By accessing or using this Website, you agree to this privacy policy. This policy may change from time to time (see Changes to Our Privacy Policy). **1. Information We Collect About You and How We Collect It.** We may collect several types of information from and about users of our Website, including information by which you may be personally identified, such as name, postal address, e-mail address, and telephone number, ("personal information"), as well as non-personally identifiable information such as information about your internet connection, the equipment you use to access our Website, and usage details. We collect this information directly from you when you provide it to us (through electronic correspondence or otherwise) and automatically as you navigate through the site through cookies, web beacons, and other tracking technologies.

You may refuse to accept browser cookies by activating the appropriate setting on your browser. However, if you select this setting you may be unable to access certain parts of our Website. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our Website.

**2. How the Information We Collect Is Used.** We use information that we collect about you or that you provide to us, including any personal information, to present our Website and its contents to you, to provide you with information, products, or services that you request from us, to carry out our obligations and enforce our rights arising from any contracts entered into between you and us, including for billing and collection, to notify you about changes to our Website or any products or services we offer or provide though it, to fulfill any other purpose for which you provide, and in any other way we may describe when you provide the information or any other purpose with your consent.

In addition, we may use the information we have collected from you to enable us to display advertisements to our advertisers' target audiences. Even though we do not disclose your personal information for these purposes without your consent, if you click on or otherwise interact with an advertisement, the advertiser may assume that you meet its target criteria.

**3. Third-Party Use of Cookies and Other Tracking Technologies.** Some content or applications, including advertisements, on the Website are served by third-parties, including advertisers, ad networks and servers, content providers, and application providers. 4.1. We may disclose aggregated information about our users, and information that does not identify any individual, without restriction.

4.2. We may disclose personal information that we collect or you provide as described in this privacy policy to our subsidiaries and affiliates, to contractors, service providers, and other third parties we use to support our business and who are bound by contractual obligations to keep personal information confidential and use it only for the purposes for which we disclose it to them, to a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of Adkev, Inc.'s assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by Adkev, Inc. about our Website users is among the assets transferred, and to fulfill the purpose for which you provide it or any other purpose disclosed by us when you provide the information or otherwise with your consent.

4.3. In addition, we may also disclose your personal information to comply with any court order, law, or legal process, including to respond to any government or regulatory request to enforce or apply our Terms of Use and other agreements, including for billing and collection purposes, or if we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Adkev, Inc., our customers, or others.

**5. Choices About How We Use and Disclose Your Information.** You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. To learn how
